Banks shall arrange stalls for providing assistance for the interested borrowers, collection of MUDRA application forms and enrolment facility under APY, PMSBY and PMJJBY. The lead role in the campaign would be taken by LIC supported by banks and GIPSA. LIC would make all logistic and administrative arrangements to organize these town hall meetings/special camps with wide local publicity by state nodal officers of LIC/GIPSA and banks in NCT of Delhi.

The Banks and Insurance companies shall target institutional entities like government offices, aaganwadi workers, industrial clusters, mela/ festival venues, colleges, PSUs, para-military organizations, industrials unites to canvass enrolments in the schemes through special camps with the support from MoF,DFS and Govt. of NCT of Delhi.

From LIC Sh. Sh. Mahender Bhadu, Branch Manager attended the meeting in absence of the Nodal Officer which was not appreciated. It was conveyed to the LIC Representative that LIC would make all logistic and administrative arrangements to organize these town hall meetings / special camps as per directions of DFS. The LIC representative informed that he is not empowered to decide on the issue of expenses/ arrangements. It was also conveyed that in future the Nodal Officer should attend the meeting.

The LIC representative was apprised of the same and was asked to confirm by 07.07.2015 that LIC is doing all the logistic & administrative arrangement in consultation with GIPSA, LDMs, Banks & SLBC co-coordinator. However, he confirmed that senior officials from LIC will meet the Convenor, SLBC-Delhi on 07.07.2015 at 3.00PM to discuss on making the logistic & administrative arrangement for the campaign.

The meeting was ended with vote of thanks by Sh. Vijay Khanduja, Canara Bank, LDM New Delhi.
