Minutes of 2nd monthly Meeting of Sub Committee to discuss/ review the progress of PMJDY, three Social Security Schemes viz. PMJJBY/ PMSBY/ APY, PMMY and other Govt. Sponsored Schemes held on 28.07.2015 at 3.00PM at Conference Hall of Oriental Bank of Commerce, Harsha Bhawan, New Delhi.

At the outset, **Shri Navleen Kundra, General Manager/ Convenor, SLBC, Delhi State** welcomed all the participants.

Sh Kundra informed the house that as per decision taken in 79th Meeting of SLBC- Delhi State held on 20.05.2015, a sub-committee was constituted, to discuss/review the progress of PMJDY, three Social Security Schemes viz. PMJJBY/ PMSBY/ APY, and other Govt. Sponsored Schemes, on monthly basis. Ist meeting of above sub-committee was held on 02.06.2015.

He further informed that to boost the progress in enrolment under these social security schemes and implementation of Pradhan Mantri Mudra Yojna (PMMY), Ministry of Finance directed to launch a campaign in every state and Union Territory across the country from 7th of July, 2015 onwards upto 31st of August, 2015, to maximise enrolments under these Schemes with a focus on Atal Pension Yojna and Pradhan Manti Mudra Yojna as the progress under these schemes is not upto the mark.

Accordingly, during the meeting of LDMs/ Nodal Officers of LIC/GIPSA/PFRDA held on 06.07.2015, it was decided to organise such a Town Hall meeting / Sp. Camp in each district of NCT of Delhi for enrolments under the above social security Schemes with a focus on APY and PMMY in NCT of Delhi as under:

He further informed that first four of above Town hall meetings have been conducted successfully. More than 500 persons attended each town hall meeting and a good number of enrolments took place under different schemes during the meeting.

He requested the LDMs, all member banks, LIC, GIPSA and PFRDA to organise the town hall meetings/ camps in remaining districts with same zeal with support / guidance of DFS, MoF and Govt. of NCT of Delhi, making wide publicity.

To have the maximum enrolments under these schemes, he requested all member banks, LIC and GIPSA officials:

- To make maximum publicity about these schemes in their area and make the public aware about the benefits of these schemes;
- Set up a helpdesks in each branch with banners and publicity material, to facilitate enrolment;
- > Organise well publicized camps in every branch, with local advertisement, publicity.
- Set Weekly goals for enrolments;
- Make target Institutional and Government offices, Aanganwadi workers, Industrial clusters, colleges for teachers and students & Industrial units for labour.

He also requested to auto debit the amount of premium in all cases enrolled under the schemes and send the premium to the concerned Insurance companies;

Sh. K. Mohan Gandhi, DGM from PFRDA made aware the participants about the Atal Pension Yojna in detail. He explained the benefits/ highlights of the Atal Pension Yojna. He also cleared the doubts of the participants on APY. He also informed that any bank wants to provide training to its staff on APY, may inform the PFRDA.

PMEGP: The progress under PMEGP is still very slow. All member banks were requested to identify minimum one case per branch under this scheme to boost the progress.

On NULM, Sh. Kundra informed that in place of SJSRY, NUML has been implemented but the progress under it is very slow. All member banks requested to ensure active participation in this scheme to have the desired results.
