

Minutes of Meeting with LDMs, FLCs and FLCCs in NCT of Delhi to discuss/ review the progress of MUDRA loans, holding of camps/meetings under PMMY after 02.10.2015 and mapping of Private ITIs, VTPs and OCs held on 11.12.2015 at 10.30 AM at Conference Hall of Oriental Bank of Commerce, Harsha Bhawan, New Delhi.

At the outset, **Shri Navleen Kundra, General Manager/ Convenor, SLBC, Delhi State** welcomed all the LDMs, FLCs & FLCCs and all other participants.

Shri Kundra showed his concern over the slow pace of MUDRA loans after campaign period i.e. 02.10.2015 and requested all the participants to achieve the disbursement targets of minimum 15 loans under Shishu category, 4 under Kishor category and 1 under Tarun category per month per branch under MUDRA Yojna during the special campaign launched from 01.11.2015 to 28.02.2016 as per directions from Mission Office, DFS, MoF, GOI.

On issuance and activation of Rupay Card under PMJDY, he stated that :


1. An analysis of data of the Banks on all India basis show that only about 32% of the RuPay cards are active. Activation of RuPay Debit cards is necessary to get the insurance claim under RuPay Card. The RuPay card needs to have swiped in an ATM or POS machine within 90 days prior to the date of incident resulting in accidental death/ permanent disability.
2. In view of the above, he requested to organize RuPay Card distribution meetings at each branch of the Bank, from Saturday (19.12.2015), where steps be taken to activate the already distributed RuPay cards.
3. The Lead District Managers (LDMs) were also requested to organize these meetings in close coordination with the District Collectors and the district Administration, who should also be invited in these meetings. Since, delivery/ distribution of RuPay Card may be pending with Post offices, Local Post Masters may also be invited in these meetings. In this regard, he briefed the guidance / instructions given by Secretary (FS) to Chief Secretaries of all States/ UTs through its D.O. No. 1/9/2014-FI (Pt.XII) (C-69306) dated 5th December 2015.
4. Further, it was also requested that Financial Literacy be also imparted in these meetings regarding process of activating the card and keeping the insurance cover alive and various benefits available under 5 schemes namely PMJDY, Pradhan Mantri Jeevan Jyoti Bima Yojna (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana (APY) and Pradhan Mantri Mudra Yojana (PMMY).
5. It was requested to furnish the action taken report / progress to SLBC-Delhi at slbc.del@obc.co.in and Mission Director at missionfi@nic.in with a copy to pande.alok@nic.in and fi-dfs@nic.in.
6. District wise progress on holding of camps / meetings for MUDRA loans after 02.10.2015 and progress under other Social Security schemes of Government of India was also discussed / reviewed. (District wise detail of holding of camps/meetings is attached).



Further agenda of mapping of Private ITIs, VTPs and OCs was taken.

1. During the meeting district wise mapping of Private ITIs was discussed with LDMs, FLCs and FLCCs and finalized.
2. On mapping of VTPs and OCs, list of VTPs was handed over to them with a request to inform the SLBC, in case there is any change in Name of the District mentioned against each VTP and they were also requested to get the job of mapping of VTPs and OCs completed latest by 16.12.2015 so that confirmation on it may be sent to DFS, MoF as desired.
