Shri K.S.Shergill welcomed all the participants to the Half Yearly meeting of sub-committee on SHGs.

Shri Shergill stated that although no difficulty is being reported in formation and opening of bank accounts of SHGs, still SHG linkage is not picking up. He requested all the members to sensitize their field functionaries to extend credit to SHGs.

Shri Shergill informed the House that the number of SHGs formed as on March 2014 is 3815 as compared to 3866 as on Sept.,2013 with a decline of 51 numbers mainly due to decrease reported by BOB. BOB in this regard has explained that during previous half year the saving accounts of SHGs were opened which were later closed resulting in decreased in number of SHGs.

Shri Avinash Kapoor, AGM, RBI requested member banks for proper reporting about SHGs formation and credit linkage. He urged all banks to report the figure correctly.

Shri Kapoor requested all banks to ensure credit linkage of SHGs which have not been linked so far.

Representative from Allahabad bank suggested members to take services of reputed NGOs for formation of new SHGs and their credit linkage.

Shri Amarjit Singh, AGM, SLBC urged member banks to organize camps and make extra efforts for formation of new Self Help Groups and linkage of remaining SHGs.
