1. Confirmation of Minutes of last meeting held on 22.10.2014.

As no comments or modifications to the minutes were suggested by the participants, the minutes of the meeting held on 22.10.2014 were taken as confirmed.

2. <u>List of Gender Resources Centre (GRCs) and NGOs operating in Delhi</u> State.

As desired by the Insurance companies, the list of Gender Resource Centres (GRCs)/NGOs in the NCT of Delhi was provided to them.

3. Name of the District level Nodal Officer of Life and Non Life Insurance Companies for all the 11 Districts of Delhi State for coordination with LDMs.

4. Swavalamban Scheme-PFRDA

The representative of PFRDA informed that 26 Banks are working as Aggregators. He was requested to provide the names of these Banks to SLBC. A yearly target of 70 cases per branch for the current financial year was allotted to each branch of the Aggregator Banks operating in Delhi. Periodic progress of achievement of the target shall be shared by PFRDA with SLBC for follow up with deficient performers.

5. Miscellaneous

After threadbare deliberations in the House, it was unanimously agreed that LDMs of all the 11 Districts of Delhi State shall convene a Districtwise meeting in their respective Districts with the Nodal Officers of Life and Non Life Insurance Companies, representatives of DRC & GRCs and Ward Coordinators of the Banks. This meeting should be held expeditiously and minutes thereof be sent to SLBC latest by 10th November 2014.

The Life and PSU Non-Life Insurance Companies were requested to participate in the Mega Camps that are being held every last Saturday of the month to impart financial literacy about the insurance products.

LDMs appreciated the effort undertaken by SLBC for giving wide publicity to PMJDY through FM Radio.
