

**Minutes of Meeting of Sub Committee to SLBC-Delhi held on 18.09.2017 to discuss/ review the progress of 6 Flagship Schemes of Govt. of India other Govt. Sponsored Schemes & district wise event on PMMY between 25<sup>th</sup> September to 27<sup>th</sup> September, 2017.**

A Meeting of Sub Committee to SLBC-Delhi was held on 18.09.2017 at 04:30 PM at Conference Hall of Oriental Bank of Commerce, Harsha Bhawan, New Delhi to discuss/ review the progress of 6 Flag ship Schemes of Govt. of India viz. PMJDY, PMJJBY/ PMSBY/ APY/PMMY/Stand up India and other Govt. Sponsored Schemes. The meeting was presided by Ms. Manisha Saxena, IAS, Secretary (Rev) Cum Divisional Commissioner, Delhi Govt. and also attended by Shri Vivek Srivastava, Asstt. General Manager, RBI; Shri Praveen Guglani, Dy. General Manager, OBC; LDMs; Member Banks NCT of Delhi.

At the outset, Shri P. Sreedhar, GM/ Convenor, SLBC, Delhi welcomed by Ms. Manisha Saxena, IAS, Secretary (Rev) Cum Divisional Commissioner, Shri Vivek.Srivastava, AGM, RBI and all other participants. A power point presentation was given on 6 flagship schemes, Aadhaar/Mobile seeding as well as setting up of Aadhaar enrolment and updation centres at selected branches.

**On PMJDY**, Sh. P Sreedhar stated that the focus is on issuance and activation of Rupay Cards, Aadhaar /Mobile Seeding & revival of transaction in Zero Balance Account.

**On PMJJBY/ PMSBY and APY**, he asked to take more initiatives to accelerate the enrolments under all these schemes particularly under APY.

**On Stand up India scheme**, Ms. Manisha Saxena, stated that the progress under the scheme is not satisfactory. LDMs should play a more active role and create better awareness in their area/district. LDMs should fix a meeting time to time with concerned DM to review the progress and to organise the camps in MSME clusters, prominent Markets and major construction sites in coordination with District Administration to accelerate the progress under the schemes.

**On PMMY**, she stated that LDMs should make available Banners and other publicity material on PMMY in DMs offices for creating awareness by them.

**On PMEGP**, Sh. Sreedhar requested member banks and LDMs to follow up with their concerned branches for disposal of all pending cases lying with them. Ms. Saxena added that if required a meeting of Banks, LDMs and KVIC officials may be arranged by her office to the resolve pending issues, if any.

**On NULM**, Sh. Sreedhar stated that progress under the scheme is very poor. On it Ms. Manisha Saxena, informed that under NULM urban poor has now been defined and briefed on latest development being made by Govt. on NCT of Delhi in the matter.

**On Joint Liability Farming Groups of "Bhoomiheen Kisan"**, All banks and concerned LDMs were again requested to take personal initiative for making finance to Joint Liability Farming Groups of "Bhoomiheen Kisan".

During the meeting Aadhaar seeding, Authentication setting up Aadhaar enrolment and update Centres & Organising of district wise Townhall Meetings/ Camps on PMMY/ Stand up India were also discussed/ reviewed.




**On Aadhaar seeding & Authentication**, Banks & LDMs were requested to give wide publicity so that target of 100% Aadhaar seeding & Authentication can be achieved.

**On Setting up of Aadhaar Enrolment And Update Centres**, he stated that as per amendment under PMLA rules, the Scheduled Commercial Banks have to set up enrolment centres in 10% of their branches by 30.09.2017 other wise they have to face a penalty of Rs. 20000/- per month per branch. He also requested the Member Banks to submit the progress on setting of Aadhaar enrolment and update centre to SLBC-Delhi.

**On Organising of district wise event on PMMY** between 25<sup>th</sup> September to 27<sup>th</sup> September, 2017, Sh. Sreedhar stated that the main Focus should be PMMY & Stand up India. The other activities i.e. Aadhaar/ Mobile seeding, Aadhaar authentication, Enrolment of PMSBY/PMJJBY and APY, opening of new accounts, OD limit of 5000/- under PMJDY, Distribution of Rupay Cards, downloading of BHIM, Aadhaar Pay App, promotion of digital payments etc. shall also be taken during the event.

The role of the Organising Bank, LDMs, other Banks and their Branches in the respective district, was made clear during the meeting for successfully organising the events.
