

Minutes of - Preparatory Meeting with LDMs called by SLBC Delhi to discuss the strategy for organizing activities during the observance of Vigilance Awareness Week 2016 (from 31<sup>st</sup> October to 5<sup>th</sup> November 2016) in NCT of Delhi held on 14.10.2016 at 2.30 p.m. at Conference Hall, Oriental Bank of Commerce, Harsha Bhawan, E Block, Connaught Place, New Delhi

At the outset, Shri K. K. Acharya, General Manager/ Convenor, SLBC, NCT of Delhi welcomed all LDMs and all other participants. Shri Acharya, thereafter, briefed on the following Action Points on observance of Vigilance Awareness Week 2016 (from 31<sup>st</sup> October to 5<sup>th</sup> November 2016).

- As per guidelines from Central Vigilance Commission, Vigilance Awareness Week is to be observed this year by all organization within the purview of the Commission from 31<sup>st</sup> October to 5<sup>th</sup> November, 2016, The Commission has chosen “ **Public participation in promoting Integrity and eradicating Corruption**” as the central theme for Vigilance Awareness Week, 2016.
- Display of banners with the following vigilance message at all Branches / Offices/public places throughout the Vigilance Awareness Week :  
“**Let us join to eradicate corruption “आईए सब मिलकर भ्रष्टाचार मिटाए”**”
- Pledge to be administered by the Heads of all Branches/Offices of the Bank on 31<sup>st</sup> October at 11.00 a.m.
- All the Branches/Offices of the bank to spread awareness about corruption and mechanism established in the banks to fight corruption and take preventive vigilance measures for which a **meeting of customers may be organized** at all offices during the week with the following agenda:
  - I. Making the customers aware of their Rights & Responsibilities.
  - II. Redressal of the grievances of customers.
  - III. Making customers aware about the harmful effects of corruption and soliciting their cooperation in combating corruption by public participation.
- **To organize “ Awareness Gram Sabhas”** for spreading awareness and to sensitize citizens on ill-effects of corruption in at least two Gram Panchayats of every branch (in rural and semi-urban areas) and by Lead bank at district level. As part of activities competitions / Melas/ Night Choupals/ Cultural Programmes etc. will be organized.
- The observance of vigilance Awareness Week may be **given wide publicity** by the Lead Bank Office / Branches.

- An essay competition amongst all categories proposed to be held. The participations who are ranked 1<sup>ST</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> may be awarded. The topic proposed is :-

**“Public Participation in promoting Integrity and Eradicating Corruption”**

**“भ्रष्टाचार निवारण एव सत्यनिष्ठा को बढ़ावा देने में जनसहभागिता”**

LDMs were also requested to choose activities out of the following proposed activities for organizing in at least 1 college and 1 school in their respective districts for creation of awareness on the Moral Values, Ethics, Good governance practices, ill effects of corruption etc. amongst the youth/ students and also to distribute prizes.

- An essay competition
- Rangoli, Painting
- Puppet show
- Nukkar Natak
- Display of Documentary films etc.

There after strategy for organizing activities during the observance of Vigilance Awareness Week 2016 (from 31<sup>st</sup> October to 5<sup>th</sup> November 2016) was discussed in length with LDMs and other participants to make the event a grand success .
